

ELIGIBILITY

A residential complex/facility with five (5) or more dwelling units on the property is eligible for this program. The complex owner's or condominium association's (or authorized representative) approval is necessary for major energy efficiency upgrades. Tenants and owners must work together to make the program successful.

Dwellings with up to four units on the property may qualify for the Home Energy Services program or the income-eligible "Single Family" program. Visit **MassSave.com** for details.

CASE STUDIES



Condominium Association with 53 units in Ashland, MA

Upon completion of the energy assessment, incentives were provided for programmable thermostats, smart strips, air sealing and insulation, and domestic hot water conservation measures and energy-efficiency lighting in the dwelling units and common areas of the complex.

Total Project Cost: \$134,236 Incentive: \$123,921 Cost to Customer: \$10,315 Annual Electricity Savings: \$38,018 Annual Gas Savings: \$8,289



Multi-Family Apartment with 6 units in Dorchester, MA

Upon completion of the energy assessment, incentives were provided for LEDs, smart strips, air sealing and insulation, and domestic hot water conservation measures.

Total Project Cost: \$12,726 Incentive: \$10,065 Cost to Customer: \$2,661 Annual Electricity Savings: \$1,339 Annual Gas Savings: \$1,331
